Issue Statement (Block #15 on PS Form 8190):

Did management at the [Station/Post Office] violate Section 215.1 of the M-39 Handbook and Section 913 of the M-41 Handbook via Article 19 of the National Agreement by failing to give at least 1 day's notice that Route(s) [route #(s)] were going to be inspected on day(s) other than the scheduled inspection date, and if so, what should the remedy be?

Union Facts and Contentions (Block #17 on PS Form 8190):

Facts:

- Management conducted a route count and inspection on Route(s) [route #(s)] at the [Station/Post Office] beginning on [date].
- 2. Section 215.1 of the M-39 and Section 913 of the M-41 Handbooks require management to provide 1 day's advance notice to Letter Carriers when management changes the scheduled day of inspection.

Section 215.1 of the M-39 Handbook states:

215 Posting Notice of Scheduled Mail Count and Inspection

215.1 A notice must be posted at the delivery unit in advance of the scheduled mail counts and route inspections, showing the beginning date of the count for each route and the day and date each route is scheduled for inspection. This notice must be posted at least 5 working days before the start of the count period. If a decision is made to inspect on days other than the scheduled date, 1 day's advance notice must be given.

(Emphasis Added)

Section 913 of the M-41 Handbook states:

913 Advance Notice

A notice giving schedule of a count week and proposed day of inspection for each route shall be posted at the delivery unit not later than 5 working days preceding start of count. <u>One day's advance notice will be given if a decision is made to inspect on days other than the scheduled date.</u>

(Emphasis Added)

 The case file includes statements from Letter Carriers showing that management changed the scheduled day(s) of inspection without providing at least 1 day's notice.

Contentions:

 Management violated Section 215.1 of the M-39 Handbook and Section 913 of the M-41 Handbook via Article 19 of the National Agreement by failing to give 1 day's notice that Route(s) [route #(s)] were going to be inspected on day(s) other than the scheduled inspection date, and if so, what should the remedy be?

Remedy (Block #19 on PS Form 8190):

- That management cease and desist violating Section 215.1 of the M-39 Handbook and Section 913 of the M-41 Handbook via Article 19 of the National Agreement in the future.
- That each Letter Carrier at the [Station/Post Office] is paid a lump sum of \$100.00 to serve as an incentive for future compliance, and/or any other remedy the Step B team or an arbitrator deems appropriate.
