Many Carriers are having issues with their OWCP claims. The big issue is that claims are being denied. A common reason for the denial is because the claims are not supported with enough information. If you file a CA2 for an occupational disease and illness for a medical condition that has developed slowly over a period of time, one of your requirements is to provide a detailed statement of your exposure to the stressful conditions that are causing the disease or illness. They ask for complete details of the conditions of employment which are believed to be responsible for the disease or illness. This allows your doctor to know exactly what it is physically that you do while at work. The statement should include details on your physical movements of what part of the body is injured. For example, if you have a right shoulder injury, you would want to explain how much you use your right arm during the day. Casing- for 1-2 hours a day, you are constantly raising your arm anywhere from waist level to over your head 18-20 times a minute. Describe pulling down-withdrawing mail from waist level to above the shoulder for 15 minutes. Loading the parcels and mail into the vehicle, re-arranging the mail while out on the street. How many deliveries do you have? How many parcels are delivered? And when dismounting for delivery, you have to describe how many times you open and close the sliding door.

Lynnwood is hard at it again. As management continues to violate the contract, the Stewards continue to grieve (and win). It's only March 9th, we're barely into the New Year and the Lynnwood Stewards have already processed 65 grievances and counting. That's 65 grievances in 27 days of Steward Time. 14 days in January, 5 days in February and 8 days in March, that's roughly 2.5 grievances per day. I'd say that was some kind of a record but last year the Lynnwood Stewards processed well over 400 grievances.

What grievances you ask. A Notice of Removal, No T-6 Pay, multiple Letter of Warnings, multiple 7 day Suspensions, multiple 14 day Suspensions, Unrequested LWOP Hours, Unscheduled Sick Leave for Approved FMLA, Missing Paychecks, To many Reneges to count, Failing to Grant Advanced Sick Leave, Parking Issues, Sick Leave on the Annual Leave Calendar, LWOP on the annual calendar, Not training CCA's on Walking Routes, Not Training CCA's on 2-Tons, Bumping off an OPT's, multiple No Uniforms Cards, Work Hours, Failing To Post Opts, multiple Dignity & Respect, Start Times, Overtime, No PS1723 Documentation, Borrowing CCA's, No Information Request Given, No Interviews Granted, Cell Phone Violations, you name it, we probably did it.

We (the Stewards) were really hoping to have a less productive year in the filing of grievances, but at this rate we just might end up filing more than last year.

3 new Lynnwood Stewards will soon be off to training. I'd like to welcome PK Strom, Joanie Durgan and David Shields. With 3 more set of trained eyes maybe management will start following the contract and less time will have to be spent filing grievances. But until then, if you're not sure of something or you have questions, don't hesitate to ask a Steward. And remember, I believe there's no such thing as a dumb question, just ask Bob James, I asked him plenty.

Retiree's Corner

I thought that it was time again to talk about the benefits of retaining your membership in the NALC after retirement, so I looked at the article I wrote for the March 2005 newsletter for ideas. I decided that it was good enough, so with the exception of this preamble and the closing remarks, this is a re-run.

If you are reading this article, chances are you are a member of the NALC, either active or retired. If you are an active member, you might be wondering why you should retain your membership after retirement. After all, when you are retired, management can't harass or discipline you so you don't need our representation anymore. Think again.

Under the Postal Reorganization study commissioned by the President, there are many proposals that would affect postal retirees, and the NALC will fight for us, but these are just proposals at this time. This article is about four things that concern retired members right now.

<u>COLA.</u> The feds are always trying to cut retiree's cost of living allowance, possibly because they think we are an underrepresented group, or maybe because they think the NALC (and other unions) will sell us out to get better bennies for the active members. The NALC fights just as hard for us as for active members.

Windfall Elimination Provision (WEP). If you have retired under CSRS but worked a job under social security before, after or during your postal employment and therefore are or will become eligible for Social Security benefits, this law penalizes you. Even though you paid into both systems, in the government's eyes, you are a double dipper and not entitled to full S.S. benefits. In fact, your benefits could be cut by as much as 55%. Private sector employees who paid into two systems (S.S. and employer pension) get both benefits. Bills have been introduced to right this injustice, and the NALC supports them.

Government Pension Offset (GPO). This is closely related to the WEP above. If you have retired under CSRS and have a spouse getting social security who dies,


We will then decide if we want to go and have pizza and salads to thank you for your time. Usually the answer is yes.

Proposed By-Law Change

Change Article 6 Section 1 by changing the words after Branch 791 to: for active members shall be the same as set by Article 7, section 2 (a) of the NALC National Constitution."

Article 6 section 1 now reads:

ARTICLE 6

DUES AND ASSESSMENTS

Section 1- The dues of Branch # 791 shall be a sum equal to two (2) hours pay for a City Carrier Grade J Step D Letter Carrier at the rate set by the National Agreement or whatever rate is set for a minimum dues structure by National (N.A.L.C.) whichever is greater, per month for active members. Additional two-dollars (\$2.00) per pay period will be added to the minimum dues structure as established by National. (Jun 05)

Change to:

ARTICLE 6

DUES AND ASSESSMENTS

Section 1- The dues of Branch 791 for active members shall be the same as set by Article 7, section 2 (a) of the NALC National Constitution. Additional two-dollars (\$2.00) per pay period will be added to the minimum dues structure as established by National. (Jun 05)

Describe twisting and reaching for the gathering of the mail for delivery if you have a mounted route. You can also say how many times on average you pull the emergency break. You want to include anything and everything that you use that right shoulder for during your normal day while at work. Having a detailed statement will help with the processing of your claim.

We are required to give management an emergency contact number. Many of us have given them our cell phone numbers. We have had many issues in our offices were management is calling us while out on the routes asking questions about packages or mail problems. While working, management has the ability to text us on our scanners for asking these questions. There is no requirement for you to answer your personal phone when management calls. Additionally, when you are not working there is no requirement to answer a call or text from management. One of the biggest issues with this is for the CCA's. Management has got into the habit of calling or texting the CCA's to come in early, come in late or not at all. This is a big problem for those CCA's that are being sent to other offices. If you are on the schedule to work at the office you are assigned to and receive a phone call or text stating you need to go to a different office, you should be showing up to the office you are assigned to, clocking on and then traveling to the different office. Mileage should be paid for the travel as well.

you would not get the same survivor or spouse benefits as a non-government retiree. Again, you are a double dipper and your "Spousal" benefits would be reduced by an amount equal to two-thirds of your annuity amount, which in many cases could completely eliminate any survivor benefits. Again, bills have been introduced to modify or eliminate the GPO.

Premium Conversion. As an active federal employee, you pay for your health care premiums with pre-tax dollars. This is money taken from your paycheck before it is subject to income tax or social security tax (for FERS employees) withholding, meaning that your taxable income is correspondingly less. Retirees have to pay for health benefits after income tax has been deducted from our full annuity, causing us to pay more income tax. The NALC supports premium conversion for retired Letter Carriers.

This is just 4 of many reasons to remain a member of the NALC after retirement, and the best part is that a retired member of branch 791 only pays \$2 per month

In closing, sign-up to become an NALC e-activist, its important, and once you retire, your automatic deduction to COLCPE stops, so don't forget to sign up for a new one, I forgot for over a year!

Congressman Rick Larsen has signed onto the following NALC endorsed bills before the U S House of Representatives. H. Res. 33 is that a sense of the House is against privatization of the USPS. H. Res. 54 is that the sense of the House to take all appropriate measures to continue six-day delivery by the USPS. H. Res. 23 is that the sense of the Congress that door delivery should continue for business and residential delivery. H. Res. 60 That the sense of the Congress is that service standards should be restored to those that were in effect on July 1, 2012. Please take the time to thank Congressman Larsen for his support of Letter Carriers and the U S Postal Service.
